**Vendor Information & Rules**  
**Red Power Round UP**  
June 16 - 18, 2016

- **Vendor spots will be assigned on a first come first served basis based upon the receipt of returned forms, not arrival at the show.**
- Maps of the swap area and directions will be sent to the vendors before the show.
- 2 complimentary wrist bands will be given to each vendor. All others will need to be purchase at a cost of \$25 each.
- "Vendor agrees to secure, at its own expense, a public liability insurance policy, with an insurance company authorized to do business in the State of Wisconsin and acceptable to Chapter 4. Such policy shall name Wisconsin Chapter 4, International Harvester Collectors, Inc., the Racine County Agricultural Society, Inc., and Racine County, Wisconsin as additional insured parties against all claims for injury or death to persons and injury to or destruction of property. The minimum limits of said insurance policy shall be one million dollars (\$1,000,000) combined single limit for bodily injury and property damage per person and per occurrence, the terms of such coverage to coincide with the term of this Agreement. Each policy shall provide that a 10-day written notice be given by the insurer to Wisconsin Chapter 4 if the insurance policy is changed or cancelled. Ten (10) days prior to commencement of the term of this Agreement, Vendor shall furnish Wisconsin Chapter 4 a Certificate of Insurance signed, not rubber-stamped, by an agent authorized to sign for the issuing company. If said Certificate is not provided, this license is void and Vendor shall not be allowed on the grounds."
- Only IH items or IH related items will be displayed because this is the National IHCC Show.
- All items which need to be licensed MUST BE. Red Power Round Up name or logo clothes cannot be sold without the approval of WI Chapter #4.
- Vendors are responsible for any/all state sales tax, if applicable.
- If a vendor has special needs, they **must** be addressed when the vendor contract is returned. *(ie: I am always next to or vend with someone else, I need semi entrance and exit room, I'm coming late or leaving early, I need to put up a tent on grass)*
- Outside spaces are 20' x 20' for \$50 each for as many spaces as desired. Spaces may also be bought 20' x 40' deep for \$100 for as many spaces as desired.
- Inside spaces are 10' x 10' for \$50 for as many spaces as desired. Each space comes with 1 table and 2 chairs. You may bring your own tables or rent extras for \$25 per table/chairs. You may also furnish your own tables and chairs. Electrical is available for inside vendors for \$10 extra.
- There will be no motorized vehicles in the inside vendor areas.
- The inside vendor area will be locked at night so you will not be able to spend the night inside the area. Spaces are available in the RV area which is close to the building for an additional fee.
- All vendors must supply their own power cords, tape to cover the cords and table coverings.
- No posting of signs or advertising outside your vending area.
- Vendors may enter the grounds at 8 am on Tuesday June 14, 2016 and must be out of the grounds no later than noon on Sunday, June 19, 2016.
- There will be no refunds for cancelled spaces after June 7, 2016.
- Vendors may bring their own golf cart, but will need to register it and provide proof of insurance.
- All weapons, fireworks, alcohol and pornography are banned from Red Power Round Up
